

JAPANESE KNOTWEED TREATMENT

FOR THE ATTENTION OF THE PROPERTY OCCUPIER

We have noticed that Japanese knotweed exists on your property.

The property neighbouring you also has Japanese knotweed and they have instructed us to treat it under our Knotweed Management Plan (KMP).

In conjunction with this we would also like to treat **free of charge** an area of knotweed within your property. The area and location of the knotweed we wish to treat on your property is quite specific and may not include for the treatment of all the Japanese knotweed present on your property. Please request sight of the neighbours KMP survey plan to see where our treatment will take place.

Concurrent and simultaneous treatment of yours and your neighbours identified knotweed areas will help us to manage the knotweed problem for your neighbour.

If you believe there is more knotweed present on your property than that we will be treating, you can request a free survey from us to provide you a price to treat all the knotweed on your property, with provision of guarantee.

Japanese knotweed is an invasive and resilient weed. Its roots and rhizomes can grow to a depth of 2m. Even after herbicide treatment has eradicated the aerial and surface growth, the deep underground rhizomes can remain in a viable state, and may do so for up to twenty years. It can re-emerge and re-grow of its own accord at any time, and especially if the contaminated ground is disturbed. If knotweed is left to grow untreated for a number of years, it has the potential to cause damage to drains, paving, paths, driveways and walls and could also encroach into neighbouring properties. **For this reason it should not be ignored.**

We would like to make a number of treatment/monitoring visits and apply chemical to the aerial knotweed growth by stem injection, knapsack spraying or leaf wiping as per below:

WHEN WILL THE VISITS TAKE PLACE?

The application of herbicide will take place during the growing season (May-Nov). We generally visit twice per year, and the timings of these visits is dependent on the knotweed growth patterns we observe.

IMPORTANT NOTES

- Please note that we have not surveyed your garden and we may not be aware of or treating the entire area of knotweed in your garden.
- We may not make all the visits scheduled and will not visit separately if access into your garden could not be arranged in conjunction with the visit to the neighbouring properties.
- This work does not provide a treatment guarantee.
